## About forklifts at work...

In many of the presentations I have delivered to teachers, questions have arisen regarding requirements for the use and operation of forklift trucks. Many teachers have asked if a license is required to drive a forklift and what safety precautions should be taken to ensure the safety of their students who are placed in environments where operating a lift truck is a major component of the job.

The Ministry of Labour has seen many serious and deadly injuries involving lift trucks. The latest resulted in the death this year of a 16 year old.

Regulations made under Ontario's Occupational Health and Safety Act require that an employer ensures that the powered lift truck operator is a "competent person".

The employer should determine competence based on the employee's knowledge and performance as laid out in the Ministry of Labour's [Guideline for the Safe Operation and Maintenance of Powered Lift Trucks](#).

This document sets standards for what a competent operator MUST know and demonstrate to be competent.

It's important to know that operating a lift truck requires a high degree of training and experience. The Canadian Standards Association in its Powered Lift Truck Standard B335-04 recommends eight hours of classroom

training and four hours of practical training before a person is ready to learn to drive a lift truck in the workplace.

There is no provincially recognized certification or license for driving a forklift. Because employers are required by law to provide job-specific health and safety training to employees, training on one particular forklift does not mean that the worker is qualified to drive a different forklift, or even the same one, at a different work site.

Some employers and training providers issue certificates to graduates of training programs, but these certificates only indicate that the person has completed that training provider's course, not that they are forever qualified to drive any lift truck in any workplace.
